The following shall be inserted after General Condition 10(d)(ii) (Determinations and Exercise of Discretion (BEC)) as General Condition 10(d)(iii):

"(iii) For the avoidance of doubt, notwithstanding anything in the terms and conditions of the Notes to the contrary, the ability of the Issuer or Calculation Agent to exercise any discretionary authority under the terms and conditions of the Notes shall be limited to exercises of such discretionary authority under which each Note of the series of Notes remains an "eligible debt security" for purposes of the Federal Reserve's TLAC rule.""
