## 1. What is this product?

Objectives	<p>The product is designed to provide a return in the form of (1) conditional interest payments and (2) a cash payment on termination of the product. The timing and amount of these payments will depend on the performance of the <b>underlyings</b>. The product has a fixed term and will terminate on the <b>maturity date</b>, unless terminated early. If, at maturity, the <b>worst performing underlying</b> has fallen below its <b>barrier price</b>, the product may return less than the <b>product notional amount</b> or even zero.</p> <p><b>Early termination following an autocall:</b> The product will terminate prior to the <b>maturity date</b> if, on any <b>autocall observation date</b>, the <b>reference price</b> of the <b>worst performing underlying</b> is at or above its <b>autocall barrier price</b>. On any such early termination, you will on the immediately following <b>autocall payment date</b> receive, in addition to any final interest payment, a cash payment equal to the autocall payment of EUR 1,000.00. ## 2. What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product for 2 years and 6 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

**To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. ## 3. What happens if the manufacturer is unable to pay out?

## 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for two different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

Disregarding the impact on your return in that scenario, the estimated entry and exit costs are estimated to be EUR 41.51 if you cash in after year 1 and EUR 31.51 if you cash in after the recommended holding period. ## 5. How long should I hold it and can I take money out early?

### Recommended holding period: 2 years and 6 months

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 12 September 2022 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
