You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

Objectives

The product is designed to provide a return in the form of (1) conditional interest payments and (2) a cash payment on the **maturity date**. The amount of these payments will depend on the performance of the **underlyings**. The product has a fixed term and will terminate on the **maturity date**. If, at maturity, the **final reference price** of the **worst performing underlying** has fallen below its **barrier price** and a **lock-in event** has not occurred, the product may return less than the **product notional amount** or even zero.

Interest: On each **interest payment date** you will receive an interest payment of EUR 42.50 if the **reference price** of the **worst performing underlying** is at or above its **interest barrier price** on the immediately preceding **interest observation date**. If this condition is not met, you will receive no interest payment on such **interest payment date**. The relevant dates are shown in the table(s) below. However, if on any **interest conditionality switch observation date**, the **reference price** of the **worst performing underlying** is at or above 100.00%, the subsequent interest payments will no longer be subject to the **interest barrier price** condition.

Termination on the maturity date: If a **lock-in event** has not occurred, on the **maturity date** you will receive:

- if the **final reference price** of the **worst performing underlying** is at or above its **barrier price**, a cash payment equal to EUR 1,000.00; or
- if the **final reference price** of the **worst performing underlying** is below its **barrier price**, a cash payment directly linked to the performance of the **worst performing underlying**. The cash payment will equal (i) the **product notional amount** multiplied by (ii) (A) the **final reference price** of the **worst performing underlying** divided by (B) its **strike price**.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlyings**, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

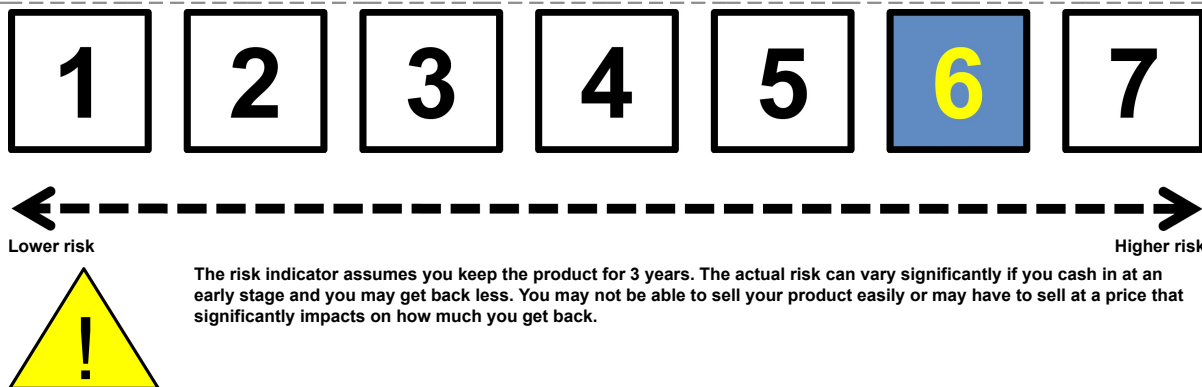

2. What are the risks and what could I get in return?

Risk indicator

This table shows the money you could get back over the next 3 years under different scenarios, assuming that you invest EUR 10,000.

3. What happens if the manufacturer is unable to pay out?

4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Disregarding the impact on your return in that scenario, the estimated entry and exit costs are estimated to be EUR 47.36 if you cash in after 1 year, EUR 47.36 if you cash in after 2 years and EUR 37.36 if you cash in at the end of the recommended holding period.

5. How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 29 January 2024 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
