You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

Objectives

The product is designed to provide a return in the form of (1) regular fixed interest payments and (2) either a cash payment or the delivery of the underlying on termination of the product. What you may receive, and when, will depend on the performance of the underlying. The product has a fixed term and will terminate on the maturity date, unless terminated early. If, at maturity, the final reference price of the underlying has fallen below the barrier price, the product may return shares of a value that is less than the product notional amount or even zero.

Early termination following an autocall: The product will terminate prior to the maturity date if, on any autocall observation date, the reference price is at or above the relevant autocall barrier price. On any such early termination, you will on the immediately following autocall payment date receive, in addition to a final interest payment, a cash payment equal to the autocall payment of EUR 1,000.00. No interest payments will be made on any date after such autocall payment date

Interest: If the product has not terminated early, on each interest payment date you will receive an interest payment of EUR 10.30. The interest payments are not linked to the performance of the underlying

Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive:

- if the final reference price is at or above the barrier price, a cash payment equal to EUR 1.000.00; or 1.
- if the final reference price is below the barrier price, physical delivery of 19 shares of the underlying and the cash equivalent of 0.95211 such shares. The value of such shares will generally be less than the amount you invested

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

When purchasing this product during its lifetime, the purchase price does not include accrued interest on a pro rata basis.

You do not have any entitlement to a dividend from the underlying and you have no right to any further entitlement resulting from the underlying (e.g., voting rights).

The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This scenario assumes that the product early terminates in May 2023 and you do not reinvest the proceeds.

This table shows the money you could get back over the next 2 years under different scenarios, assuming that you invest EUR 10,000.

3. What happens if the manufacturer is unable to pay out?

4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for two different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

The "Total costs" in the table above represents in monetary terms the aggregated amount of costs associated with the investment, assuming the product performs in line with the moderate performance scenario. The "Impact on return" represents how much the expected costs of the product would affect your return in such scenario. Disregarding the impact on your return in that scenario or any early termination event, the estimated entry and exit costs are estimated to be EUR 31.10 if you cash in after 1 year and EUR 21.10 if you cash in at the end of the recommended holding period.

5. How long should I hold it and can I take money out early?

Recommended holding period: 2 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 25 November 2024 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
